2. Subject objectives

	The goal of this course is to introduce students to the International Organizations theory and the use of this theory to understand international relations. The course aims to show the analytic tools available to understand
	how
	International Organizations work, their effects, and how they could be better designed. Two groups of IO -
	International Governmental Organizations and International Non-Governmental Organizations - are discussed.

3. Prerequisites

This course is addressed to upper-level undergraduate students who are expected to have knowledge about the general history of International Relations in the 20th century.

4. Learning content

Code	Topic blocks (semester: 5)
Wyk1	Introduction: The State and International Organizations (IO); sovereignty; definition of "International organizations". 2 hours
Wyk2	The sovereignty of state and globalization. Is globalization undermining the sovereign state system? The place of IO in world politics. The history of the League of Nations. 3 hours
Wyk3	Three traditions of thought in understanding the problem of international order: realism, internationalism, and universalism. Power and interdependence. Does military power still matter in international relations? 3 hours
Wyk4	Two general approaches to the study of IO: the regime approach ("black box" approach) and the institutional approach. The question of the bureaucratic structure of an IO (what it can do and cannot do). 3 hours
Wyk5	Efficiency and ideas, or rationalist (neoliberal institutionalist) and reflectivist (constructivist) methodologies. The dilemma of collective action ("a prisoners' dilemma")
Wyk6	The United Nations and its system. Structure. The UN, sovereignty, and power. The GA. The Security Council. The Secretariat. ECOSOC, the ICJ, and the Trusteeship Council. 3 hours
Wyk7	Collective security. The case of the occupation of Iraq by U.S. forces in 2003. Does the UN need some significant reforms? 3 hours
Wyk8	Human rights and humanitarian aid. 3 hours
Wyk9	Money and trade. The IMF, the World Bank, and the WTO. 3 hours

Wyk10	The role of IO in development. The United Nations Development Programme (UNDP), and the United Nations Conference on Trade and Development (UNCTAD). 2 hours
Wyk11	Types of NGOs and the role of chosen NGOs in contemporary international relations. 2 hours
